## On Patrol



This past year proved to be a very busy year as we closed out our books with 5,625 incidents reported to the Police Department compared to 3,725 cases filed in 1990.

The sobriety check point program proved to be quite effective during the month of December with 4 check points conducted, 462 vehicles checked, and 7 arrests for drunk driving. Total DUI's for the month ended at 17 arrests with an average blood alcohol content of .19%.

There were 6 motor vehicle accidents reported with the majority occurring on Mondays and Thursdays.

Other incidents included: 6 assault & batteries, 2 assaults, 3 breaking and entering, 17 child abuse and neglect cases, 1 curfew violation, 15 intoxicated juveniles, 12 intoxicated

minors, 12 vandalism reports, 3 drug arrests, 18 runaways, 2 attempted suicides, and 5 gun/knife/weapon incidents.

With more incidents being reported, again we are asking for community support by keeping an eye on your neighbors property or house when they are away. Did you know that for the year 1991 that in the community of Warm Springs there was approximately \$145,500 in stolen items reported. Of that figure only 35% of the items stolen have been recovered. If you know of, see, or accept items you believe have been stolen, call the Police Department.

\* Call the Police Department to report suspicious activities, drunk drivers, etc.

\* Get involved by supplying a description of the person who committed the offense. What are they wearing, how tall are they, how much do they weigh, etc.

\* If they have left the scene, get a description of the vehicle or license plate number, and where they were last seen or where they might be going next.

For those of you who have helped the Police Department this past year, Thank You and keep calling. You don't have to leave your name.

In the area of Fish & Game, several big game violations were reported this last season with one Tribal member being apprehended and charged with an Elk out of season after crashing a pickup that he was driving. Another case involved a small fire that led officers to a gut

pile that led further to a search warrant being obtained and evidence discovered of not only a cow elk but several deer taken illegally. Formal charges were brought against a non-Indian, however, several Tribal members who were accomplices in this act were not charged but referred to the Fish & Wildlife Committee for further action.

For the month of December, there were total of 127 contacts made with 7 citations issued and 21 warnings given out. Remember that an officer out in the woods or on the river will make contact with you. If you know of violator's that you may have seen while taking care of your business, let them know. We're working to protect all of our natural resources. The Fish & Game division includes: Supervisor-Larry Holliday, Officers-Harry Miller, Donnie Winshut, and Anson Begay.

Work will also be done with parents and students to create a team that works for the student's best interest. The recruiters will discuss with Librarians books that are necessary for students to identify scholarships and successfully apply to the scholarships that they are eligible for.

## Vehicle Pool policy noted

Portions of the Vehicle Pool Policy will appear in the next two issues of Spilyay Tymoo. The following is the fourth section of the Vehicle Pool Policy Manual.

### 4.0 Misuse and Abuse of Vehicles

(a) Personal Responsibility. Any driver misusing or abusing tribal vehicles or has an accident may lose

their driving privileges and may be held personally responsible for any damages to the vehicle. The driver is responsible for an amount up to \$250.00. The Safety Board reviews all incidents of vehicle abuse or misuse and a warning may be issued. Further violations may require action of the department supervisor. (Second accident - \$250, possible loss of job. EM).

### 4.1 Accidents

All accidents must be reported. Accident reports may be obtained at any of the following places: Police Department, Insurance Office, Vehicle Pool, Oregon State DMV.

### 4.2 Safety Board

The Safety Board is established to review accidents, misuse of, and high costs of vehicles. They meet bi-monthly and the Board has final authority regarding accidents, misuse, and high costs.

(a) Membership. The Safety Board consists of five members appointed by the C.E.O. to serve two-year terms.

(b) Driver's Rights. The driver must be given the opportunity to present testimony, produce evidence and witnesses, and reserves the right to legal counsel at the driver's expense.

(c) Board Decisions. The Safety Board's decision is issued no more than five working days after the hearing.

(d) Notification. Notification of an accident is given to Police Department, Vehicle Pool Supervisor, insurance coordinator and department supervisor within 48 hours of the accident. Failure to report an accident may result in suspension or job loss.
