In 1987 Evette Patt from Warm Springs was in an automobile accident which was a result of alcohol abuse. She was not the driver (the driver suffered only minor injuries) however, she had a head injury and was in a coma for several months. The doctors did not know if she would ever recover from the results of the head injury or be able to walk again. Evette has paralysis on the right side of her body and is now able to walk with the assistance of a cane.

This is a remarkable young women whose inner strength has allowed her to overcome her disabilities and her problem with alcohol. Evette not only acknowledges and accepts that her physical and mental limitations are a direct result of alcohol abuse she has written letters to our office expressing her concerns to her people in Warm Springs...in her own words; "I

hope no one else from over there will go out trying to act cool to have to learn lessons about alcohol as bad as I did.

Evette is currently living in an Adult Foster Care home in Springfield, Oregon, she awaits the day when more services for our disabled are brought to Warm Springs so she may return home. However, she has taken advantage of the resources that are available to her and has enrolled in several courses at Lane Community College. She has just completed a "Workplace in Social Skills" class

offered by the adults with Special Needs Program. She is very proud of her certificate of completion and asked us to share her accomplishments with her community. We are also very proud of Evette and commend her strength and determination to overcome her disabilities and teaching us that life is worth living no matter what the circumstances.
