House party nets 12 arrests On April 30, officers responded to the senior citizen housing area on a reported party-noise complaint on Olallie Lane in which a total of 12 persons were brought to jail.

On arrival, officers made contact with a female juvenile resident who reported that her grandmother was not home who had hired a sitter to look over things. On further investigation, the responsible party was found to be intoxicated that led to the discovery of a total of four juveniles of which three were found intoxicated

along with eight adults. Three of the four juveniles plead guilty in juvenile court for being in possession of intoxicants by consumption. In addition, the four juveniles are being investigated for injury to public property because the police unit in which they were being transported sustained damage.

Dogs at school Officers spent nearly eight hours, off and on, attempting to catch a female dog in heat that caused quite a ruckus at the Warm Springs grade school May 6.

First reports of the animal came in to the WSPD at about 8 a.m. with two officers responding to round up the animal. Unsuccessful for nearly two hours, another call was placed in the afternoon where a total of six officers converging on the school grounds in the fourth attempt to capture the dog that had other dogs close by. Various fights between the dogs broke out as officers attempted to separate the canines.

A citizen, Larry Cabell, is credited in the capture who was helping in the morning hours then returned and captured the dog after officers were led on a chase from the school grounds down to across from Macy's.

Several other canines were also captured during the roundup who were then returned to their owners with a warning to keep their animals off the streets and school grounds. Victim's Impact Panel

DMV News Of our most recent automobile crashes occurring on or off the reservation, the following information will assist in the event you become a

Oregon state law requires that drivers involved to file a report with DMV within 72 hours of the time the accident occurred. If damages to "any one" piece of property totals \$400 or more, and/or personal injuries are incurred by any persons involved,

the report must be filed. Tribal members involved in such accidents on the reservation are exempt from Oregon state law, but non-Indians are not exempt, and must

Here's where a dilemma might occur: An Indian and a non-Indian are involved in a motor vehicle accident on the reservation, the accident results in injury to one of the drivers. The non-Indian driver files the required accident report with DMV.

The Indian driver does not file. The DMV receives the report from the non-Indian and waits for the report from the Indian driver; this report never arrives. DMV then sends a warning notice to the Indian driver advising him or her they must file the report or risk having his/her Oregon state driver's license suspended or privilege to apply for one suspended. If the Indian fails to respond, his/her license or privilege to apply is then suspended and must undergo considerable cost and effort to be rein-

One must weigh the possibilities and consider the outcome of the action he chooses to take.

If a driver reports his accident to DMV, the accident is likely to appear on his driving record. However, if he files he will avoid the risk of having the license suspended along with the hardships one would endure to have it reinstated.

Corrections News by Bob Whittenburge

We're well into spring and again we have several changes taking place in the corrections division. What is noted here occurred in March 1993. Concerns of Inmates

Inmates have stated they felt their pass requests were not being taken to the courts for approval. I met with the inmates to show them the documentation that all passes are being taken to the Court and the court clerks have signed forms to show the pass requests have been signed.

As of April 16, 1993, the Court revised the blanket order concerning passes and work release requests. All such requests are to be reviewed by the Parole and Probation Office prior to being forwarded to the tribal

Passes are being submitted once a week, on Friday, no later than 8 a.m. to corrections and then forwarded to the probation and parole office no later than 10 a.m. Requests are returned by noon the same day.

The number of persons being sent to the Warm Springs Correctional Facility is growing and the Corrections Divisions is having quite a time housing the inmates. The over-all capacity at the Warm Springs jail is 48, male, female and juveniles, on a daily basis. During April, a total of 1,159 in-

mates were booked into the facility. This number is based on a daily count of inmates. Total monthly capacity for April was 1,440.

The inmates consisted of 1,048 adult male and female inmates, 37 juvenile males and 47 juvenile fe-

This information is related to the community to let residents know the need for a larger facility. The number of inmates has increased over the past several months.

The total number of female juveniles in custody in the corrections facility in April was 47. Thirty-seven juvenile males were in custody. This should be of great concern for community members. Perhaps we need to remember that the youth are in the care of the parents and that proper guidance is not being provided.

The majority of juveniles brought into the Corrections Facility were either "Juvenile in Need of Supervision" or Juvenile in Possession by Consumption." There has been a noticeable increase in the number of juveniles charged with Juvenile in Possession by Consumption. (WSTC 360.420)

Reservations are now being accepted at 13 overnight campgrounds for the period between Memorial Day and Labor Day weekends. Campsites are available at 37 other overnight parks on a first-come, first-served basis. Reservations must be made in writing or in person to the park desired. Reservation forms and additional information may be obtained from any state park office, as well as many chambers of commerce, Motor Vehicles Division and Oregon State Police offices.

Availability of campsites in all reservation state parks and general camping information on many other parks may be obtained until Labor Day weekend from the State Park Campsite Information Center. Outof-state and Portland residents call (503) 731-3411. The toll free number for other Oregon residents is 1-800-452-5687. The center operates weekdays from 8 a.m. to 4:30 p.m.

Beginning April 16, overnight camping fees will range from \$9 for a primitive campsite to \$16 for a full hook-up site at a popular destination campground. A current state park campground receipt will permit free day-use access in 26 parks charging a day-use fee May 8 through September 26. The day-use fee is \$3 per vehicle and a new \$20 annual permit will be available later this month.
