Accident claims tribal member

A single-car accident on tribal highway 3 Thursday, September 22 claimed the life of 28-year-old Juanita Blodgett.

Blodgett, member of the Confederated Tribes of Warm Springs, was heading south toward Warm Springs on the Kah-Nee-Ta Highway when she failed to negotiate a corner near the Dry Creek Bridge. Blodgett'scar, a 1993 Ford Festiva, rolled and came to a stop off the highway. Warm Springs Chief of Police Don Courtney said that investigation reports state that alcohol was a contributing factor in the cause of the accident.

Blodgett was transported to Mtn. View Hospital and later Air Lifted to St. Charles Medical Center in Bend. She died in the early morning hours of September 24.

Warm Springs Police called Clackamas County Sheriff's office to assist in the investigation, which continues.

Keep cards

The convenience of an ATM card far outweighs the inconveniences. says proponents. The ATM cards are accepted freely in most stores and businesses and consistent use of a card assists in record keeping.

However, consumers should be aware that some banks charge a transaction fee each time cash is withdrawn from another bank's machine. Merchants may also charge additional fees for ATM card purchases. Immediately record and deduct any fees, along with the purchase or transaction amount to avoid overdrafts.

Do ask about transaction or other fees. Select a PIN that's easy to remember, but not so easy that someone else can figure it out. Don't keep your PIN written near or on your card. Report a missing or stolen card immediately. Failure to notify your bank or report unauthorized transactions means you'll lose any money illegally withdrawn from your ac-
