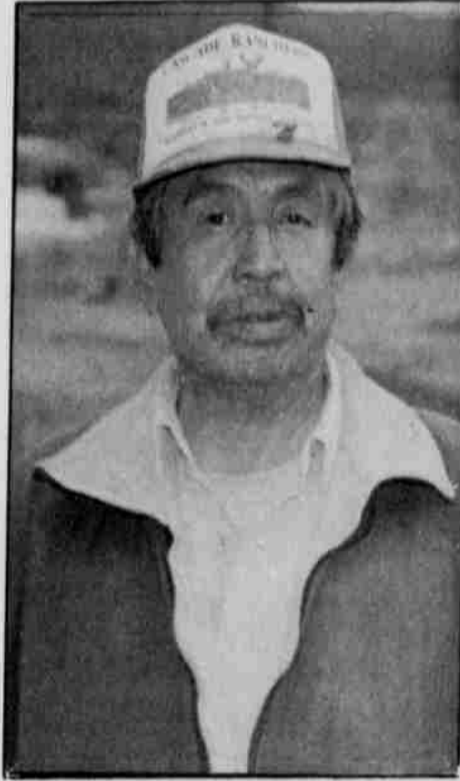

Served the Tribal Government about 25 years starting at 75 cents an hour as a clerk, taking minutes for Tribal council and Tribal Court, keeping and updating all records, which is now done by entire departments. Did accounting work and eventually went into the Loan department and worked my way to up office manager and that is where I retired.



Bertson Simtustus

I, Bertson Simtustus, was born in Simnasho. My mother was Elizabeth Sam Simtustus, and my father was Johnnie Simtustus. I started school in the summer of 1937 in Chemawa Indian School in Salem, Oregon. In the fall of 1937, I started school here at the Warm Springs Boarding School till 1948 when I graduated from the eighth grade. I joined the Marine Corps on March 6, 1952. I took my basic training in Ma-

rine Corps Recruit Depot in San Diego, California. After finishing boot camp, I transferred to Camp Pendleton, California for further training and in May of 1953, I was transferred to Korea for 14 months, then I was transferred back to Camp Pendleton. I was then transferred to Adak, Alaska to a guard attachment for six months and on April 30, 1956, I was discharged from the USMC with an honorable discharge. In 1958, I started work at Dahl Pine Lumber Company, until it burned down in 1961.

I married my first wife Nellie Annette Garry in October 1956. Had one son out of her and lost one. I lost my wife July 1965. I remarried twice after that, but ended in divorce both times.

Most of my life, I worked with race horses, working with Tom Estimo in Portland Meadows, Long Acres and all the race tracks in California.

I was most honored to be nominated for the Tribal Council by Earl Squiemphen. It is going to be an awesome experience for me.

I am an excellent listener. I hear what others have to say.

I base my decisions on an enormous amount of valid, up-to-date information and what is positive for all things concerned. I have positive expectancy of succeeding in all areas of my work and take all setbacks as temporary.

Most importantly I would like to thank my wife Beulah, my brother and mother for their encouragement and support.

For the nomination to the 20th Tribal Council by Neda Wesley. I thank her for the confidence and support.

My views have broadened somewhat as to what issues are important to the members, now and for the future, they are all important.

If I were to select one issue over the rest it would be employment. I believe Tribal members have been long overlooked in opportunities for employment and opportunities for advancement.

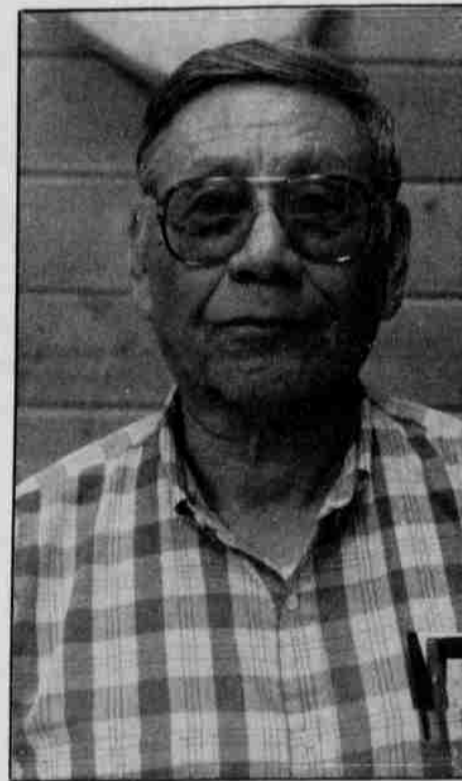
