### Road closures noted

The W110 (BIA Route 17) has been closed to traffic between its junction with the W300 and W114 roads. The road that is closed lies west of Highway 26 near Butte Creek.

The road was damaged last February during the flood and erosion has continued to be a problem. Butte Creek has been subject to heavy sediment loads due to the erosion and ongoing impacts forced resource managers to impose the closure.

Temporary repairs were made to the W110 road in order to minimize affects on the creek and surrounding environment, but permanent repairs cannot be made until next spring. The decision to close the road prior to the season's first rainfall will lessen any impacts which might have resulted from allowing traffic to use the road through the winter.

The bridge over Shitike Creek near the old boy's camp is still out and will not be replaced until next summer. The Bridge, a part of the B200 road was washed out during the Feb-

#### ruary flood. The road on both sides of the bridge remains open.

## On-line webnet offered

Chinook, World Wide Wed Catalog of Native American Arts, Crafts and Food Products went on-line September 4, paving the Indian highway on the Internet. The effort is creating opportunity for economic expansion in Indian Country by linking hightechnology with tradition and culture. It is a project of the Oregon Native American Business and Entrepreneurial Network (ONABEN). Its business purpose is to enable artists to increase sales and profits without expensive travel.

Chinook is creating market opportunities for artists by providing them exposure to Internet users around the world and will accept their payment for products and services by credit card. Categories include basketry, dolls, jewelry, masks and carvings, paintings, mixed media, Native foods, prints and posters, sculpture, weaving and traditional arts (cradleboards, drums, flutes, teepee, etc.)

Chinook requires that all products be handmade and produced by or offered by a Native American or tribal organization. Products must be unique or have an original design and be suitable for the product's usual and customary life, use or function with a minimum retail value of \$75. Artists who subscribe will have their photo placed directly on the Web, a brief biography and a list of the work offered. The products are listed with a photo, brief description, shipping cost and estimated time it will take for delivery

ONABÉN's On-Line Catalog Coordinator Laura Nihoa explains, "For example Mrs. Grant of Tennessee sees a photo on the web of Laina Green's drums. She places an order with her American Express (or Mastercard or Visa). We receive the order and verify funds. The order is good and we notify Laina that she has sold two painted drums. As soon as she delivers the drums to ONABEN or a designated shipper, we write Laina a check for her work. The drums are then shipped to Mrs. Grant".

Chinook invites all artists with entrepreneurial spirit and wanting to expand their present business minus the additional overhead cost, to join the high-technology world of Chinook's World Wide Web Catalog of Native American Arts, Crafts and Food Products.
