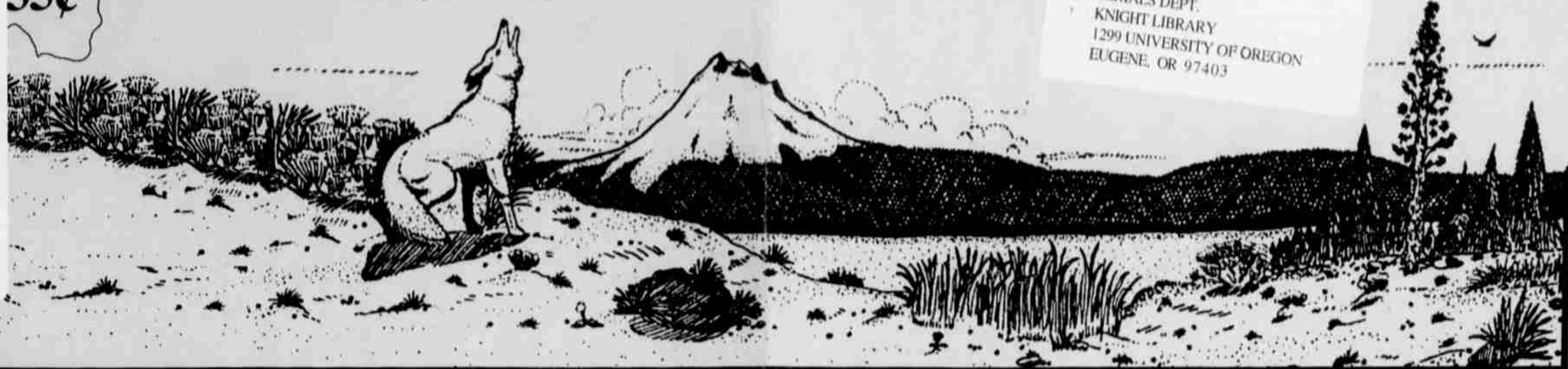

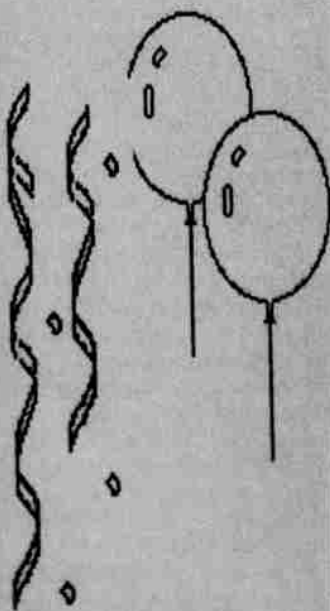

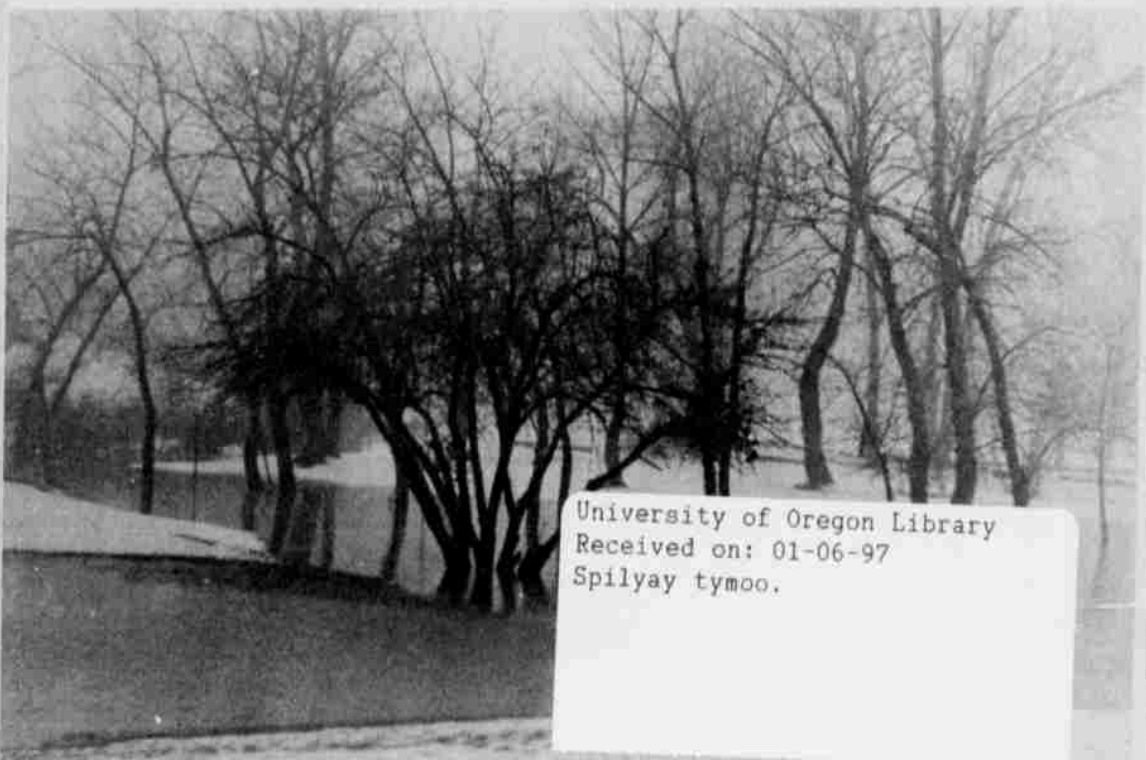

Warm Springs residents are surely wondering if a second 100-year flood could hit Warm Springs in less than 10 months. Anything is

possible....just ask those of us tolerating the gray, gloomy skies, sodden ground and murky waters—not unlike the weather of last February.

As area rivers and creeks overflowed their banks, crews were busy attempting to keep the damage at a minimum. Filled sandbags have been amassed and are ready if needed.

Residents no doubt feel the recent rains makes them "old hands" at combatting ugly weather. And, as the Boy Scouts say, "Be prepared."

Spilyay has put together a survival guide to the flooding. (Some recommendations are serious, while some others are not.)

Be sure to have plenty of bottled water on hand. It is hard to determine what impact the high waters have had on the water treatment plant. Have candles and a flashlight handy. Also, be sure to have fresh batteries in your radios and flashlights. Have plenty of non-perishable foods on hand and keep your wet-weather clothing close at hand.

It also helps to have a good sense of humor, a terrific sense of adventure and to have your insurance premiums paid.

Council seeking Board members

Tribal Council of the Confederated Tribes of the Warm Springs Reservation would like to announce the following vacancies:

Tribal Credit Enterprise Board of Directors (5 positions); these are divided into three classes: Class I consists of two directors, one enrolled member & one non-member, term to expire January 1, 1998.

Class II consists of two directors, one enrolled member & one non-member, term to expire January 1, 1999.

Class III consists of one member who shall be an enrolled member of the Tribes, term to expire January 1, 2000 or until their successors are appointed and take office. Must have a reputation for industry, dependability, honesty and integrity. It shall be an initial and continuing qualification for members of the Board that they have no loan with the Tribes that is in a delinquent status.

Warm Springs Forest Products Industry Board of Directors (3 positions Class I & II)

Class I shall consist of one individual whom shall be a member/non member of the Tribe, term expires December 31, 1999.

Class II shall consist of two individuals one of whom shall be a mem-

ber of the Tribes and one non-member, term to expire December 31, 1999. Must have an interest in the economic and social development of the Tribe and it's membership, possess expertise in forestry, forest products, manufacturing, finance, banking or some other field which would benefit the Enterprise.

Warm Springs Composite Products Board of Directors (1 position Class I)

Class I shall consist of one individual who shall be either a member or non-member of the Tribes, term to expire December 31, 1999. Must have an interest in the economic and social development of the Tribe and it's membership, must possess expertise in marketing, management, manufacturing, finance, banking and some other field which would benefit WSCP.

Warm Springs Local Housing Authority (2 positions)

A Commissioner may be a member or non-member of the Tribes and may be a member or non-member of the Tribal Council.

Warm Springs Power Enterprise (3 positions, Class I and II)

Class I shall consist of one director who shall be an enrolled member of the Tribe or non-member, term to

expire January 1, 2000. Must have an interest in the economic development of the Tribe and it's membership, expertise in the field of energy or related matters.

Class II shall consist of two directors, one of whom shall be an enrolled member of the tribe and one non-member, term expires January 1, 1998.

Warm Springs Gaming Enterprise (1 position Class I)

Class I shall consist of one individual who can be a member or non-member of the Tribes, term expires December 31. Must be interested in the economic and social development of the Tribe, possess expertise in gaming, accounting, law, law enforcement, computers or some other field which would benefit WSGE.
