Indian Law conference set

On October 17-18, 1997, Northwestern School of Law of Lewis & Clark College and the Indian Law Section of the Oregon State Bar will host an Indian law conference of considerable significance. Inspired by the 10th anniversary of the 1987 book by Charles F. Wilkinson, American Indians, Time, and the Law, the conference will focus on the status of tribal sovereignty. In his book, Professor Wilkinson provided a spirited defense of tribal sovereignty and the status of tribes as separate governmental and territorial entities in the U.S. constitutional system. Based on a detail study of Supreme Court decisions, he concluded that tribes had achieved at least some stability in their "historic task of creating workable islands of Inianness within the larger society.

Professor Wilkinson, the Moses Lasky Professor of the Law at the university of Colorado, will be the featured speaker at the October conference. He and other notable scholars and practitioners in the Indian law field will explore judicial and legislative developments over the last ten years to assess the current status of tribal sovereignty. On the first day, speakers will address such topics as cultural racism, taxation, tribal court jurisdiction, and leading edge litigation. On the second day, speak ers will examine the issue of tribal sovereignty in the Pacific Northwest and will focus on gaming and economic development, cultural resources protection, and self-gover-

The conference will also feature many other leading scholars, practitioners, and tribal leaders, including Kathryn Harrison, Chair Confederated Tribes of the Grand Ronde; Kriss Olson, U.S. Attorney, District of Oregon; Howard Arnett, Karnopp. Petersen; Professor Michael Blumm, Northwestern School of Law of Lewis & Clark College, and Dean Rennard Strickland, University of Oregon School of Law

Section 1. Initial Board of Directors The business and affairs of WSTC shall be managed and controlled by a Board of Directors.

Section 2. Number. The Board of Directors shall consist of not less than three nor more than five directors. Directors may be members of the Tribes or non-members of the Tribes who are interested in the economic and social development of the Tribe and its members and who possess expertise in marketing, management, manufacturing, finance, banking or some other field which would benefit WSTC, provided, at all times a majority of the members of the Board of Directors shall be members of the Tribe, no person shall concurrently serve on the Board of Directors and the Tribal Council.

Section 3. Classification and Term

(a) The Board of Directors shall be divided into three classes, designated Class I, Class II and Class III, as follows: (1) Class I shall consist of one individual who shall have an initial term in office expiring on December 31, 1998 next following the Class I director's appointment by the Council, or until a

successor is appointed and takes office. (2) Class II shall consist of one or two individuals who shall have an initial term in office expiring on December 31. 1999 (one year after the expiration of the initial term of the Class I director), or until their successors are appointed and take office.

(3) Class III shall consist of one or two individuals who shall have an initial term in office expiring December 31, 2000 (two years after the expiration of the initial term of the Class I director), or until their successors are appointed and take office. (b) After the expiration of the initial

Class I: Non-member position Section 1. Establishment of the Tribal Credit Enterprise Board of Directors. There is hereby established a Tribal Credit Board of Directors consisting of five members to be appointed by the Tribal Council in accordance with the provisions of this Charter. All credit activities of The Enterprise will be under the supervisory review and direction of the Board of Directors.

Section 2. Classification and Terms of Office of the Board of Directors.

(1) The members of the Board of Directors shall be divided into three classes, designated Class I, Class II and Class III as follows:

(a) Class I shall consist of two directors. One director shall be an agree to forgo the loan in return for a enrolled member of the Tribes. The other Class I director shall be a non-member interested in the social and economic development of the Tribes and who has expertise in the field of credit or related professions. The Class I directors shall have an initial term in office expiring

January 1, 1998.

(2) Selection of Board of Directors. The first five members will be appointed for terms of one, two and three years. At the end of the first year and each year thereafter, as each term of office expires, the term of office will be for three years. Members will continue to serve until their successor are appointed.

(3) Record of Appointments. A record of all appointments to the Board of Directors will be maintained by the Secretary/Treasurer of the Tribal Council.

(4) Members of the Board of Directors must have a reputation for industry, dependability, honesty and integrity. It shall be an initial and continuing qualification of the Board of Directors that they have no loan with the Tribes that is in a delinquent status.

Environmental Quality Incentive Program (EQIP)

The EQIP Program replaced four conservation program including the Agricultural Conservation Program (ACP). It is available primarily in priority areas where there are significant natural resource needs and objectives determined by local work groups involving Natural Resources Conservation Service (NRCS), Farm Service Agency (FSA), Cooperative Extension Service and the Confederated Tribes of Warm Springs. In Jefferson County, the only priority area identified to date has been the Seekseequa watershed project.

Funding is also available for resource concern areas which are those portions of the county not identified as a priority area. EQIP applications will be accepted throughout the year but a designated signup period has been set for August 18-29, 1997.

The Jefferson County FSA Committee election will be held this year on December 1, 1997, in Local Administrative Area (LAA) 2 (Area B) which is north and east of Madras. Eligible voters have the right to nominate candidates of their choice by petition. Blank petitions (FSA-669A's) may be obtained at the Jefferson County FSA Office, 241 SW 3rd Street, in Madras.

Each petition submitted must be (1) limited to 1 nominee in Local Administrative Area 2, (2) signed by the nominee, indicating willingness to serve, if elected, and (3) postmarked or delivered to the Jefferson County FSA office no later than October 27, 1997.

Persons nominated should be currently engaged in the operation of a farm or ranch and be well qualified for committee work. A farmer is eligible to be a Jefferson County FSA Committee member if the farmer lives in the LAA and is an eligible voter. County FSA committee members may not hold positions in certain farm and commodity organizations, if these positions pose a conflict of interest with FSA duties These positions include functional offices such as president, vice president, secretary, and positions on boards or executive committees. Secretary of Agriculture, Dan Glickman, announced that Catastrophic Crop Insurance (CAT) will be available exclusively through private insurance agents, beginning in the 1998 crop year. Previously, the CAT insurance was available through both the Farm Service Agency and private insurance companies.

Non insured Assistance Program

The NAP Program has replaced the old disaster program for crops not insured by Catastrophic Insurance. This includes all commercially produced agriculture commodities grown for food or fiber except wheat, barley, oats, potatoes and sugar beets.

Producers suffering a 50 percent or greater loss of a crop due to a natural disaster must file a FSA-574 (Request for Acreage/Disaster Credit) within 15 days of the date the disaster occurred or damage to the crop became obvious. The deadline to file would be no later than July 1 of the next crop year. The damaged crop must not be destroyed so as to allow farm inspection of the specific acreage involved.

Producers must also file an acreage report on form FSA-578 the earlier of 15 days before the crop is harvested

NAP payments are payable at 60% of the established market price when a county suffers a 35% area wide loss on any eligible crop.
