It appears that Loan Deficiency Payments (LDP) may be available again this year due to low commodity prices. To be eligible for a loan or LDP the farm growing the commodity must be enrolled in a Production Flexibility contract (PFC). Commodity loans mature nine months from the month they are approved.

Field direct LDPs are for producers who have already marked their grain through forward contracts or pass title of the grain upon delivery. If this is the case it is very important that you complete a CCC-709 prior to harvest. Failure to do so will results in the grain being ineligible for LDP. **CRP Weed Control**

Oregon Legislature approves innovative tribal fish program

The Oregon House of Representatives Thursday passed HB 3609, a bill that allows Columbia River to deviate from the state's fish policy, a move that may ultimately call into question the definition of the term

This bill allows some tribes to manage fish with innovative methods that could change the way we look at saving our moat endangered species,

The bill's author, Rep. Jason Atkinson, R-Jacksonvill, said, "this bill is about restoring fish. It's about bringing people together, from all sides of this issue, with the sole

purpose of bringing the fish back."

Under the bill, the Confederated
Tribes of the Warm Springs and Umatilla Reservations, as well as the Nez Perce Tribe, will be allowed to plant hatchery fish, bred from wild stocks, into rivers and streams above

the Bonneville Dam.

The current wild fish policy, administered by the Oregon Depart-ment of fish and Wildlife, has reduced the number of hatchery fish introduced into streams for fear they would crowed out the native popula-

Rep. Atkinson has long said that if we are serious about returning fish, we need to be flexible in how we manage them. And artificial propagation can be a valuable tool in recovering our lost

salmon runs, he said, "the tribes have a proven track record for return-

Atkinson says this is an attempt "to conserve, protect and restore salmon," his definition of conserva-

Wildfire management meeting set

An informational meeting will be held July 7, 6-8 p.m. to inform homeowners how to protect their property from wildfire and noxious weeds. The meeting will be held in the Fire Management training room inside the Forestry complex.

Instructors will show homeowners how to determine whether their property is at risk of being lost to a wildfire and how they can take precautions to reduce that risk and instructors will discuss the identification and control of noxious weeds. All homeowners are invited to attend the evening session.

Among topics to be discussed during the meeting will be buffer zones and how to maintain them. The Fire Management staff will teach

homeowners how to defensible space around their home and how to reduce the amount of flammable vegetation within the buffer.

The crew will also cover the appropriate methods for pruning trees, maintaining a green lawn and providing access to a homesite, which makes it easier for firefighters to do their job in case of an emergency. Other topics to be addressed in-

clude the location, or relocation of wood piles, the best choice of roofing materials, what to do in case fire strikes, the types of equipment used in fighting standards for fire protection in rural housing zones.
