

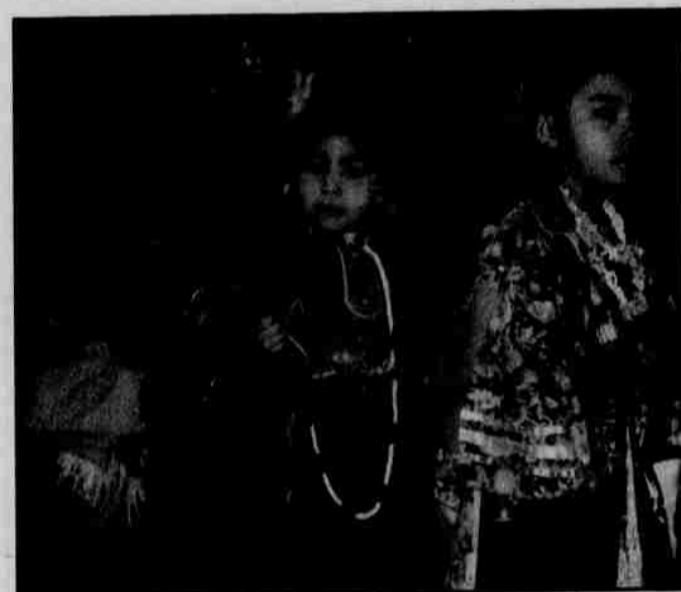
Junior Miss Warm Springs

Each of these members offers a wide range of experience and expertise to the WSVR Program.

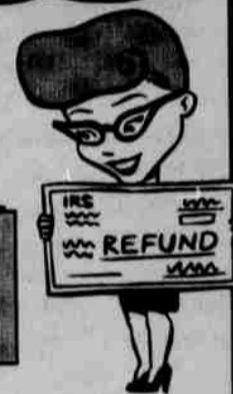
The program goal is to assist Native Americans with disabilities to obtain, maintain, or become promoted in em-
