Fire fighters, medics deserve community respect

On behalf of Warm Springs Fire and Safety, we, the fire/ medics, are asking the community of Warm

Springs to help our department. Here is what we are asking: Bear with us when no one is at the station, or the ambulance is a long time coming.

There are only two people at each station. Each station is cov-

ering an area of hun-Hello, from dreds of square Pastor Rick miles. Each area has people and houses

scattered over a wide area. The Agency station covers the bulk of the population of Warm Springs. That means medical house calls, medical jail calls, medical motor vehicle accidents, medical calls at Kah-Nee-Ta, High Lookee Lodge,

and walk-ins at the station after IHS clinic hours.

Also, fire calls: grass fires, alarms, car fires, house fires, etc.: stuck fingers in bikes, beads in the nose, rescue calls for motor vehicle accidents. You see the list can continue with things that the fire/medics do for you.

If you see where I am going, our problem is time, distance and people. When the station

staff is out on a call, the call and transport to Madras can take up to two hours to com-

The next call during this twohour time has to be covered by volunteers, off-duty medics, or staff from Madras. Usually, the staff from Simnasho will come down to the Agency. Now for a short time, the two staff members are covering the entire res-

Now with all this said, let us talk about the call volume. Our small department has the same numbers as Redmond. We do it with one-third the staff. Does a daily miracle come to mind?

So, bear with us. Our small staff and volunteers will push it to the point of exhaustion and pain to help this community.
