

## IHS helps with new ambulance

Warm Springs Fire and Safety recently received an ambulance through an Indian Health Services program.

The ambulance is a 1994 vehicle that has been refurbished. Formerly the ambulance was used by a New Jersey emergency rescue agency. The vehicle arrived in Warm Springs just last week.

Warm Springs Indian Health Services Director Russ Alger and Fire Chief Dan Martinez worked together in acquiring the ambulance.

The additional ambulance will help Fire and Safety meet the emergency rescue needs of the reservation, said Martinez. The vehicle, like the other ambulances, will be located sometimes at the Warm Springs fire hall and sometimes at Simnasho, said Martinez.

Indian Health Services (IHS) has now donated a total of nine ambulances to different reservations in the U.S. Besides Warm Springs

Fire and Safety, other agencies that have received ambulances through IHS include the Crow Creek Sioux Tribe Ambulance Service, the Lower Brule Sioux Tribe Ambulance Service, and the Big Horn County Ambulance Service in Montana. The Choctaw Nation also received

one. The ambulance that arrived in Warm Springs will need some modification to meet the Oregon ambulance code. Currently, the vehicle complies with New Jersey standards.

The ambulances were provided to mainly rural agencies

that to increase access to care for underserved populations, according to a news release from IHS. "The lack of emergency transportation in Indian Country is a major issue," said Tommy G. Thompson, Secretary of Health and Human Services.

## Ad campaign presents tribal view

The Confederated Tribes have taken out informational advertisements in *The Oregonian* newspaper.

The ads are intended to provide information to the people of Oregon about the Confederated Tribes.

The tribes have initiated this project because of the close working relationship between the state and the tribes. Economic development, such as gaming expansion, is an example of the types of projects that require cooperation between the Confederated Tribes and the state of Oregon.

The first ad ran in *The Oregonian* on Thursday, Jan. 30, and featured a color photograph of Warm Springs Chief Delvis Heath and his granddaughters Kristy and Delvina.

## Head Start funds offered

Nearly \$300,000 is available for Early Head Start services on the reservation.

The money is available through the Head Start Bureau, Administration for Children and Families, U.S. Department of Health and Human Services.

Public and private non-profit or for-profit organizations can apply for the funding.

Early Head Start serves pregnant women, infants, toddlers ages 0 to 3, and their families.

The deadline to apply for funding is April 11.

(Continued from page 1) superintendent position, desires to recommend two qualified Indian candidates for the position."

The Council made their recommendation in order of preference, with Calica being the first recommendation, and Young the second, according to the resolution.

The Council vote on the matter was 5-1. The vote was taken by secret ballot.

The permanent position of Warm Springs Agency superintendent has been vacant for over a year and a half. During that time, the position has been filled on a temporary basis, with Gerald Henrikson the most recent acting superintendent.

The BIA has a close working

relationship with the tribal government. The bureau works with the tribes on key natural resource issues, such as timber. Roads and social services are also part of the bureau's responsibility to the tribes.

The tribal recommendation for the superintendent is given careful consideration, said Speaks. "I take the recommendation very seriously," he said. "It is a bureau policy that we consult with the tribes."

The recommendation is also reviewed by the deputy commissioner of Indian Affairs in Washington, D.C. "The expectations of the superintendent are very high," he said. "It is important that a good relationship exist between the tribal governments and the bureau."
