# Patt: New position is a natural step up

Also, they said, Patt has strong political relationships with other tribal leaders, governors, landowners and members of Congress,

Patt was elected to Tribal Council in 1998, and re-elected in 2001. He has served as Council chairman during that time. He said his intention was not to seek a third term. Instead, he intended next year to return fulltime to his position as the Confederated Tribes Natural **Resources Branch senior policy** advisor. However, he said, the CRITFC executive directorship is a natural step up from that job.

He said that he will make no sweeping changes at the commission: "The course was charted many years ago by the council members of the four tribes that formed CRITFC," he said.

In looking to the future at CRITFC, Patt said: "It's not likely that the biological or legal landscape will change anytime soon."

But, he said, "One issue that encompasses a lot of challenges we have is the renogiation of the Columbia River Fish Management Plan, including harvest of course, but also production and rebuilding commitments."

Besides his work on the Tribal Council, Patt is a member of the Board of Regents of the Museum at Warm Springs, and has served as a member of the Kah-Nee-Ta board of directors.

He is a member of the board of directors of the Institute for Tribal Government at Portland State University's Hatfield School of Government. In 1991 Patt earned a bachelor's degree in journalism from the University of Oregon. His hobbies are fishing, golf and photography.
