The Confederated Tribes of Warm Springs already has a well-established and active Victims of Crime office, but the same is not true of other tribes in the state, said George. One large reservation in the state, she said, has only one person handling all of the domestic violence and sexual assault victims assistance duties. Clearly, this is much too large a caseload for one person, said George.

Another problem is lack of victims shelters available to Indian people, who can find it very hard to live at non-Indian shelters because of cultural differences. All too often the victim chooses to return to an abusive situation rather than stay at the shelter, said George.

Along with the survey, another upcoming project of the coalition will be the production of a documentary video on the subject of domestic violence and sexual assault in Indian Country. The project will involve all of the tribes in the state, said George.

The coalition also plans to develop a training program for people whose work is providing assistance to Indian people who are victims of domestic violence.

"Now, there is no standard domestic violence assistance

training for Indian Country," said George.

The Indian Country Coalition Against Domestic Violence and Sexual Assault is funded by a federal grant. The coalition began in 2002,

when Marie Calica, director of

Warm Springs Victims of Crime, learned that federal funding was available for the creation of such an organization. Calica now serves as the president of the board of the coalition. Vice president is Marvin Garcia, who works in social services with the Klamath Tribes.

Before opening the office recently in Madras, George worked out of her home.

George's background includes work with the Wenatchee Police Department, where she served as an advocate and later as a trainer in self-defense tactics. She served as a liaison between the court system and the victims of crimes.

She has a degree in criminal justice and a graduate degree in social work.

Her co-worker Debra Kalama has a background in business.

In simplest terms, the goal of the coalition is, "To empower Indian victims to live healthier lives."

In the long-term the goal is stop the cycle of abuse: If a child grows up in an environment of domestic abuse, then as an adult the individual is more likely to display the same behaviour.

## Some frequently asked questions about clinic appointments

Question: Why am I placed on hold when I call for an appointment in the morning?

Answer: A large number of calls come into the clinic between eight and 10 o'clock in the morning. On some days 20 to 30 calls may occur within a half hour.

Since it is not possible for one nurse to answer all those calls has been installed, so the staff answering the phones are able to see how many calls are waiting, and they can call for additional help during busy times.

Question: Why does the nurse on the phone ask me all those questions, when all I want is an appointment?

Answer: Each day in the clinic there are a given number of appointments available either with a doctor, a nurse practitioner, or a registered nurse.

While the triage nurse speaks

We will usually try to get you an appointment with your "designated" provider. If your provider is not available you may be asked who you would like to see or who you usually see if your doctor or practitioner is not in.

The phone nurse also begins preparation for your appointment. For example, lab work or x-rays may be ordered, results from referrals may need to be faxed, etc. We can do that before your visit, in order to make your visit go faster with less waiting. Many times people seek appointments when they really need an order for a med refill, medical advice, or the results of a medical test, and often the nurse can help make that happen without waiting for an appointment time (some medications do require a visit for a refill order so you may be asked what the medication is).

If you have a designated provider, your provider's nurse can also help with these kinds of requests, and you may not need to wait for that appointment. nurse practitioner when I get in the room.

Answer: Just like calling in for your appointment, the nurse is often checking to see if there are other things you will need for your visit. Lab work can be done while waiting for the doctor or nurse practitioner, and this saves you time.

The nurse may also screen for safety and health issues such as nutrition, exercise, tobacco use, domestic violence, etc., or be able to find you health information about your problem while you are seeing your doctor or nurse practitioner. Answer: An appointment to see a doctor, nurse practitioner, or nurse involves more than the time set aside with the provider.

When arriving at the clinic your first stop is with patient registration to update demographic information, then you sign in with the medical receptionists, the nurse aide will take vital signs, and the RN will order laboratory tests or x-rays if needed.

These are actions taken prior to your 15-minute appointment time so all information is available for you and your provider to discuss.

at once, we now try to have several people answering the phones during those times. Your call still may be placed on hold, but your call will be answered in the order you called in.

The nurse must also determine if you have a medical emergency that needs immediate attention. Question: Why does the nurse ask so many questions when she or he is just taking my vital signs? I just have to repeat myself to the doctor or the

Question: Why does my 15 minute appointment take so long? Your appointment with the provider may result in additional needs.
