such as working with Credit Enterprise, payments, property maintenance, non-sufficient

funds, etc. Assistance, such as counseling, delinquincy workout agree-

ments, subsequent loans, etc. Tribal Credit would like to extend an invitation to all tribal members who have active home loans with Credit to review the orientation guide.

The orientation guide summarizes the information needed to know about the Warm Springs Credit Enterprise Home Loan Program once a loan has been approved.

No home loan will be closed until a Credit Enterprise staff member has reviewed the information with the applicant, and the applicant has signed an acknowledgement of the review.
