Richard Louis Crane

Richard Louis Crane passed away February 25. He was 26.

Mr. Crane was born January 6, 1978, to parents Douglas Crane and Clarice Smith Crane. Mr. Crane was a fire fighter

for the Confederated Tribes. He is survived by his parents, Doug Crane of Lapwai; and Clarice of Warm Springs.

He is also survived by sons Rich Winfield Danzuka-Crane, and Syrus James Crane, both of

Warm Springs. He is survived by brothers James Crane of Warm Springs, and Douglas Crane Jr. of Lapwai; and sister Michelle Crane of Lapwai.

Lillian Maynard

Lillian Maynard was born to Tine and Rose (Teeman) Frank on April 17, 1932. She lived at the Old Camp on the outskirts of Burns until the late 1950s, when her mother passed away. She then went to live with her aunt Bernice Teeman at New Camp. Lillian moved to California to attend business school and then returned to Burns in the late 1960s.

Throughout her life, Lillian served her people. In 1948, at 16 years of age, she became the youngest person to serve on a committee for the Burns Paiute Tribe.

Later, Lillian was instrumental in the successful land restoration, of 771 acres, for the Paiute Tribe. During her lifetime, she served the tribe as a councilwoman, law clerk, and sat on several committees, enrollment, culture, law and order, and housing. She continued to speak on



behalf of the elders. Also, she worked for the Chamber of Commerce of Burns and served as a member of the Commission on Indian Services between 1997-2001.

Lillian had a great love for the land and spoke for the protection of the Steens Mountain area and the tribal allotments as well as the preservation of the traditional use areas of the Paiute people.

She was a strong supporter of the development of govern-

ment-to-government relations with the State of Oregon.

Lillian enjoyed speaking her first language and wanted the younger generation to learn and to respect their culture and language.

Lillian passed away on March 3, 2004, at St. Charles Hospital in Bend. Funeral services were held on March 6 at the Silversmith Building on the Burns Paiute Reservation. Pastor Gene Luttmann officiated. Indian people from Idaho, Nevada, California and Oregon were in attendance. Her parents and two brothers, Scott and Eldon Jim, preceded her in death.

She leaves behind nieces, Bucky Holliday of Warm Springs, and Caroline Underwood and Doreen Zacharias of Portland, as well as numerous relatives of the Teeman family of Burns.

Ivy Elizabeth Matter Hilty

Ivy Elizabeth Matter Hilty of Madras died Feb. 29. She was 94. Ms. Hilty worked in Warm Springs as Home Economics Extension Agent.

Ms. Hilty was born July 23, 1909 near Hooker, Okla., to Emil and Hedwig Matter.

She attended high school in

Optima, Okla., and graduated from Panhandle A&M College in 1937. She married Arthur Hilty in 1940.

Mrs. Hilty taught home economics in Oklahoma for several years. Then, upon moving to Central Oregon, she taught home economics at Culver High School, and then as an Exten-

sion Agent in Warm Springs, and was a professor emeritus of Oregon State University. Mrs. Hilty wrote a bird column for The Bulletin, and was a founding member of the Central Oregon Audubon Society.

She also judged food at county fairs.

Tribal census update

A total of 1,073 tribal members age 18 and over have not completed their tribal census Questionnaires.

Although 80 percent of on-reservation "heads of housing units" have been counted, this is the minimum count needed in order to challenge the U.S. Census.

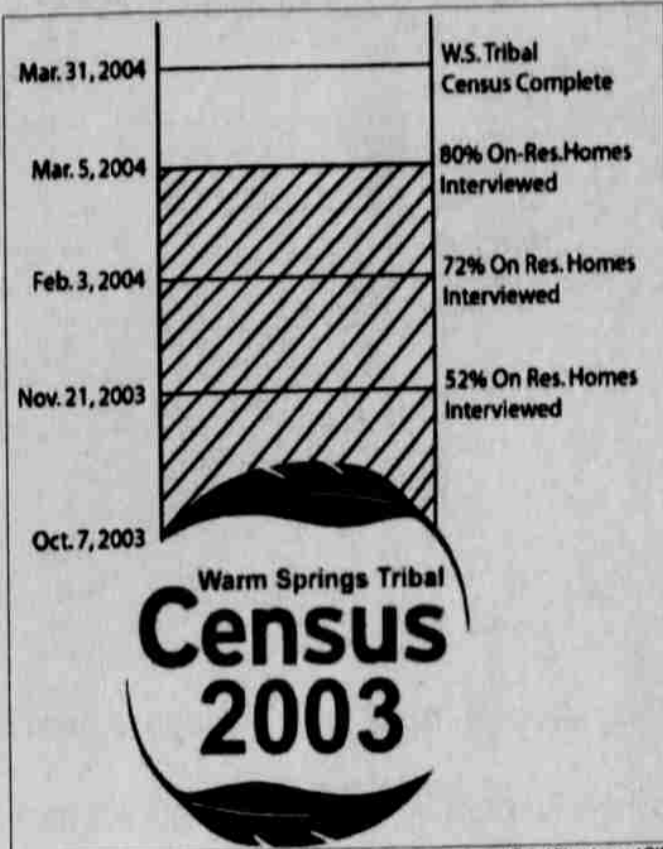
If you are the head of a housing unit, it is very important for future funding of the reservation that you now contact Vital Stats.

Some of the problems being encountered are:

No. 1. People who have changed their names in the last several years are showing up in the Vital Stats system differently than individuals are reporting. For instance, Jolene E. Atencio was counted, but Jolene Estimo is listed on the "Uncounted List." If your name is on the "Uncounted List" and you have been counted, please call Vital Stats to let them know what name you used and what name is on the Uncounted List.

No. 2. Some individuals maintain more than one residence, so it is difficult to determine where they live. We need to record information for each individual for the time period December 31, 2003-March 31, 2004. Secondary Sources can be very helpful with this.

No. 3. Non tribal members who reside in Warm Springs. We only have 19 of 51 Questionnaires completed for the Hamlets. We need to

count every resident that lives on the reservation.

No. 4. Many enumerators have dropped off Questionnaires that have not been returned. If you have a question on your form:

A. Complete the form the best you can and circle the items you are unsure of, leave it blank send it in and an enumerator will attempt to call you back to complete it. List a phone number and preferred time on your form.

B. Call the Vital Stats office (553-3252), and they can assist you.

C. If you choose not to respond to an individual question, indicate "no response" (rather than leaving it blank) and complete the questions you are willing to respond to.

No. 5. Many say they have already been counted. There have been a couple of other surveys recently. If your name is on the list please call Vital Stats and allow them to com-

plete the form with you, again, if necessary.

Besides these, there are multiple administrative issues that are being documented so that the Tribal Census process can be improved for next count in 2009.

At this time the Tribal Census Team is asking community members of Warm Springs to come forward as a "Secondary Source" on behalf of family and friends on the Uncounted List.

This list will be updated and posted at the post office, administration building, Indian Health Services and e-mailed out to all tribal employees for the next two weeks. Even if you know very little information, you can complete a form for a friend, family member or neighbor that is on the "Uncounted List." This type of community spirit will be greatly appreciated and will ensure a successful count and benefits for years to come.
