This hearing will not be a full hearing on the merits of the case; you must appear and defend against a complaint that you failed to obey the order of the court. If you fail to appear as so ordered, the Tribal Court shall enter a complaint for contempt of court and issue a warrant for your arrest. The Confederated Tribes of Warm Springs Reservation of Oregon vs. Harold and Priscilla Blackwolf, defendant. Case No. IN135-04. To Harold and Priscilla Blackwolf:

You are hereby notified that the above cited case(s), as filed in the Warm Springs Tribal Court, has been scheduled for trial/hearing at 9 a.m. on January 19, 2005.

You are hereby ordered: to be and appear at the Warm Springs Tribal Court at the time and date shown, to defend against the charge(s). You may be represented by yourself, by an attorney, or by a spokesperson at your own expense. You may bring any documents you believe are relevant to this cause, and you may bring witnesses to testify on your behalf. You may request the court to subpoena your witnesses; however, you must submit your list of witnesses no later than two weeks prior to trial; failure to do so will not be considered sufficient reason to postpone the trial. If you have questions, you should seek legal advice immediately. If you fail to appear as so ordered, the Tribal Court may enter a complaint for contempt of court and issue a warrant for your arrest. the case will be heard at this hearing, including evidence you wish to present. You must appear to present your argument or the other side will automatically win. The petitioner, Allied Recovery Inc., may then be given all that is asked for in the petition for overdue account. The petitioner will be present at the hearing. If you desire to personally argue your side of the case, you may have a legal aide, spokesperson or attorney appear on your behalf at your expense.
