By this notice you are summoned to appear in this matter at a hearing scheduled for 10 a.m. on Nov. 22 at the Warm Springs Tribal Court. All of the facts of the case will be heard at this hearing, including evidence you wish to present.

You must appear to present your argument or the other side will automatically win. The petitioner, Patricia Allen, may then be given all that is asked for in the petition for conservator/guardianship.

The petitioner will be present at the hearing. If you desire to personally argue your side of the case, you may have a legal aide, spokesperson or attorney appear on your behalf at your expense. If you have any questions, you should seek legal advice immediately. Judge Lola Sohapp.

You may request the court to subpoena you witnesses; however, you must submit your list of witnesses no later than two weeks prior to trial; failure to do so will not be considered sufficient reason to postpone the trial. If you have any questions, you should seek legal advice immediately.
