Record number of visitors at Eagle Watch

Respect for each other and respect for Mother Earth are what makes an event like Eagle Watch 2005 so important, Warm Springs tribal member Rudy Clements said Sunday.

Clements' talk was part of the Warm Springs' Native American presentation at the 10th annual Eagle Watch at Round Butte Overlook Park Sunday.

The weekend-long event gave the nearly 450 visitors the opportunity to see bald and golden eagles at various points overlooking Lake Billy Chinook and learn about the birds that frequent the area in several demonstrations and talks from local biologists. The number of visitors this year was the most ever for Eagle Watch.

"When we use the Mother Earth, that what it's here for," Clements said. "We shouldn't feel bad about using it, but one of the things that we have to keep in mind when we do use Mother Earth is that we revere it, that it's very sacred.

"If we can do that the best we can every day, the seven generations of the future will be pro-get along, the better we can work together, the better we can take care of Mother Earth, the better we can keep from fighting one another and having wars and destruction of things, the better that seven generations are going to be."

That, he said, is what he val-Part of the celebration each ued about Eagle Watch, as "one of the most important events of

Eagle Watch, presented every year the last weekend of February since 1996, exists "to educate and build awareness," Eagle Watch organizer Paul Patton, of Oregon Parks and Recreation Department, said.

"The eagle is the focal point," he said, as the weekend is a celebration of the land and environment and its wildlife.

In the sunny and balmy Sunday afternoon, the majority of attendees indicated they had seen eagles flying over Lake Billy Chinook. And if they hadn't brought binoculars, one flew low to the ground above the overlook to give the assembled a good look and a final salute to the weekend.

Along with the Confederated

number of Madras and Jefferson County businesses and a few wildlife and raptor enthusiast groups, along with Warm Springs Power Enterprises, The Museum At Warm Springs, and Kah Nee Ta High Desert Resort and Casino.

Tuckta and other dancers from the Quartz Creek Drummers and Dancers performed in full regalia, including members of the audience gathered around, including the serpentine Eel Dance, intended to cleanse and dedicate the spot for the presentation.

The presentation included Tuckta's moving Eagle Dance and concluded with a traditional round dance. Clements told the assembled group that he, as a matter of Native tradition, gave the first drum he had ever made to Patton, for his work at presenting Eagle Watch each year.




