Public comment opportunity on U.S. EPA air permit

The U.S. Environmental Protection Agency (EPA) is planning air permit for wood products facility in Warm Springs, Oregon. The 30-day public comment period ends April 30, 2005. The EPA has prepared an initial draft Clean Air Act Title V permit to operate for the Warm Springs Forest Products Industries (WSFPI) facility located at Highway 26, Warm Springs, Oregon, Warm Springs Reservation. This permit also establishes conditions under which WSPFI can replace four existing boilers with one new boiler. The facility is owned by the Confederated Tribes of the Warm Springs Reservation of Oregon. WSPFI is a sawmill located in Jefferson County, Oregon. The facility produces green and kiln dried lumber. Hoggged fuel (waste wood and bark) purchased off site and produced on site is burned in boilers to produce steam to heat lumber drying kilns and to generate electricity in three steam-powered turbines. The facility is required to obtain a Clean Air Act Title V permit to operate because it has the potential to emit more than 100 tons per year of particulate matter, fine particulate, nitro-

gen oxides, volatile organic compounds, and carbon monoxide. Because the facility is located within the exterior boundaries of the Warm Springs Reservation and because the Confederated Tribes of the Warm Springs Reservation does not have an EPA-approved Title V operating permit program, it is EPA's responsibility to issue a Title V permit to WSPFI in accordance with 40 CFR Part 71. The draft permit compiles all Clean Air Act requirements that apply to WSPFI and establishes monitoring and recordkeeping to assure compliance with those requirements. In addition, at WSPFI's request, the permit contains requirements that limit potential emissions from certain emission units at WSPFI and that will become enforceable upon permit issuance. Including limits on emissions from the new and existing boilers allows the boiler replacement project to avoid EPA's "Prevention of Significant Deterioration Program" under 40 CFR 52.21. The permit also contains owner-requested enforceable limits on hazardous air pollutant emissions (HAPs), thereby making WSPFI a minor source of HAPs and not subject to certain federal standards under 40 CFR Part 63. **How can I get more information?** You can review copies of the draft permit, the "statement of

How do I comment on the permit? Any interested person may submit written comments on the draft permit. Written comments must be received by EPA on or before April 30, 2005. Please address all corre-

If you believe that any condition of the draft permit is inappropriate, you must raise all reasonably ascertainable issues and submit all reasonably ascertainable arguments supporting your position by the end of the comment period. Any documents supporting your comments must be included in full and may not be incorporated by reference, unless they are already part of the administrative records for this permit or consist of tribal, state or federal statutes or regulations, or other generally available referenced materials. These proceedings are subject to the administrative requirements of 40 CFR 71.11.
Will there be a public hearing? You have the right to request a public hearing on this draft permit. Requests for a hearing must be received by EPA on or before April 30, 2005, and contain your reasons for requesting a hearing. If a public hearing is held, the comment period will be extended through the date of the public hearing. Requests for a public

hearing should be submitted to Chuck Flood at the above address.
Will my comments be considered? All comments received during the public comment period and public hearing (if one is held) will be considered in making a final decision on the permit. The final permit is a public record that can be obtained on request. EPA will prepare a statement of reasons for changes made to the draft permit and responses to comments received and will send them, along with the final permit, to everyone who comments on the draft permit.
