You are hereby notified that the above cited case, as filed in the Warm Springs Tribal Court, has been scheduled for a show cause hearing at 9 a.m. on May 18, 2005. You are hereby ordered to be and appear at the Warm Springs Tribal Court at the time and date shown, to show cause for failing to appear on an overdue account. This hearing will not be a full hearing on the merits of the case; you must appear and defend against a complaint that you failed to obey an order of the court.

If you fail to appear as so ordered, the Tribal Court shall enter a complaint for contempt of court and issue a warrant for your arrest. If you have any questions, you should seek legal assistance immediately. Judge Wilma Ann Smith.
