Along with other departments, we are presently planning a family wellness conference for October 2006. Other items on our agenda are: six-week women's support group beginning June 27 to Aug. 1, 2006 (contact Sara Scott), men's batterers (contact Rachel), sexual assault response team, Soaring Butterflies, Warrior Spirit and Domestic Violence classes.

There are three types of elder abuse: (1) Neglect - being left alone or deprived of needs. (2) Verbal abuse - insulting,

If you have a father, mother, aunt, uncles and/or grandparent who is an elder, treat them with kindness and love. If there is only one family member caring for an elder, give them a break, offer them respite. The elders are our resource. Viola and Sara also facilitate the women's support group in the

Rachel Smith received training to facilitate "Creating a Process for Men who Batter." She works in conjunction with the arresting officers who respond to incidents of family violence. She also works with Probation and the Tribal Court.

Battering is a social learned behavior; it is not a result of substance abuse or mental illness. Domestic violence is a pattern of assault and coercive behaviors including physical, sexual and psychological attacks, as well frightening, humiliating, threat- as economic coercion that is

used against the intimate part-

Curriculum used in class places great emphasis on actions, intent and beliefs behind acts of violence and/or intimidating behavior. It is important to get the participant to begin taking responsibility for his or her behavior. A participant who is going to change must accept responsibility for his or her vio-


