Order to Show Cause

Confederated Tribes of Warm Springs Reservation of Oregon vs. Aaron Wyngarden, defendant. Case no. CV197-08. To Aaron Wyngarden:

You are hereby notified that the above cited case(s), as filed in the Warm Springs Tribal Court, has been scheduled for a show cause hearing at 9 a.m. on December 5, 2008. You are hereby ordered to be and appear at the Warm Springs Tribal

Court at the time and date shown, to show cause: Why you should not be excluded permanently from the Warm Springs Reservation. This hearing will not be a full hearing on the merits of the case, you must appear and defend against a complaint where you were found guilty by default. If you fail to appear as so ordered, the tribal court shall enter a complaint for contempt of court and issue a warrant for your arrest. If you have any questions, you should seek legal assistance immediately.
