Pinkham leaves CRITFC

Jaime Pinkham, Nez Perce tribal member and watershed department manager for the Columbia River Inter-Tribal Fish Commission has said good-bye to CRITFC and the Columbia Basin. His departure comes after four and a half years of dedication to salmon restoration and tribal treaty fishing rights.

Pinkham led CRITFC's government-to-government relations with the federal government and the Northwest states. Pinkham will become vice president for the Archibald Bush Foundation of Saint Paul, Minn.
