Council Chairman Green then broke the tie, in favor of making the S-T and COO appointments on Monday.

The tribes are in a financial position where action is and will be required without delay, Chairman Green said. "In the interest of time, I think we need to move forward with the S-T position today," he said.

The Council by secret ballot then chose Jake Suppah as S-T, and J.P. Patt as COO.

Chairman Green, Vice Chairwoman Patt and acting Secretary-Treasurer Mike Collins agreed to contact Suppah to dis-

cuss salary and when he might be able to start as S-T.

The new Council discussed the issue of travel, with a consensus that limited travel is a priority. "I think we have all heard from the members about Tribal Council travel," said Councilwoman Patt.

Chief Heath said that in the past there were rules regulating Tribal Council travel, with travel proposals requiring Council approval.

Councilman Scott Moses said travel by the tribal committees also needs to be limited, as the tribes are facing a serious financial situation.
