7. This is a subsistence fishery; there is no harvest limit within the tribal allocation of 7,500 pounds. Subsistence is defined by Tribal Code 340.100.
8. Pursuant to Warm Springs Tribal Code 340.310 (13), the use of alcohol or drugs is prohibited when fishing under claim of treaty rights.
9. Pursuant to Warm

Springs Tribal Code 340.700 and 340.140, penalties for violations will be strictly enforced to ensure compliance with regulations.

10. Pursuant to Warm Springs Tribal Ordinance 68, Section 490.500 and Section 490.510 (8), the sale of fish caught for subsistence purposes is prohibited. Commercial sale of fish is not allowed.
