
Tribes assume stewardship of research institution

The Columbia River Inter-Tribal Fish Commission has assumed stewardship of a nationally renowned ocean and estuary research institution. The move is to better link knowledge of the Columbia River and the Pacific Ocean.

The Center for Coastal Margin Observation and Prediction was transferred in May in an agreement between between CRITFC and the Oregon Health & Science University.

The Center for Coastal Margin Observation adn Prediction, or CMOP, is dedicated to the study of estuaries; and blends science, education and regional out-

Integral to its creation was a pioneering infrastructure for the observation and



Coastal Margin Observation and Prediction researcher deploys a remote-controlled underwater drone. With the device the researchers collect water samples at varying depths and locations, and use onboard sensors to measure a variety of physical, chemical and biological conditions of ocean water.

simulation of the flows and ecosystems of the Columbia River estuary, featuring open access to scientific data and tools.

"This is a tremendous ca-

pacity-building advance for the Columbia River tribes," said Jeremy Red Star Wolf, chairman of the tribal fish commission.

"Our professional river and salmon management staffs have wanted more ocean and river connectivity in research, applied science and management. CMOP will help deliver that. I want to commend the OHSU and CRITFC staffs for putting the pieces together and making this transition happen."

The information is used by fishers, shipping companies, aquaculture businesses, weather forecasters, public utilities, search-andrescue teams and countless others to make informed decisions.
