The 2021 Student After-School Work program is now open. This is a chance for young people to gain work experience, and earn high school credits. Some of the terms

of the program:

The student must have a recommendation from a high school counselor, have good attendance, and be on track to graduate. The

program is open to youth ages 14 to 21. College students, between ages 18 and 24, may apply.

Work placement will be determined based on the student's future and current career goals. Work sites are on the reservation, or in Jefferson, Deschutes, Crook or Wasco counties.

Apply online at the Confederated Tribes job portal. Call WEDD to complete the intake. Other terms: Provide tribal identification, Social Security card, proof of residency; and a letter that the youth is available and allowed to work. All students need a resume. Males of age must be registered with Selective Service.
