Wreck, apparent suicide at Mill Creek

U.S. Highway 26 was closed for approximately four hours Saturday, May 4 after a vehicle crashed off the Mill Creek bridge on the reservation.

The vehicle, identified as being driven by Kyle Kircher, 30, of Happy Valley, left the roadway and landed 250 feet below the bridge on the canyon floor at around 1 a.m., May 4. Kircher was declared deceased at the scene.

Shortly before the wreck, he had earlier been reported as sui-

cidal.

The car was located in the canyon by Warm Springs Police at 1:05 a.m. on May 4. Search and rescue of the vehicle was delayed until daylight for safety concerns of responders.

The highway was closed at approximately 2:30 p.m. to begin recovery of the vehicle and driver. Oregon State Police stated current evidence supporting the crash was intentional.
