As of earlier this week at least, the federal government had so far failed to reach an agreement on funding its functions. As a result, the U.S. government is shut down until further notice; the following is a comment from the Social Security Administration to the situation:
We recognize that your organization plays a critical role, and we want to provide you with informa-

tion to help you guide the people you serve.
We want you to know that during the federal government shutdown, payments to all people who currently receive Social Security benefits and Supplemental Security Income, or SSI, will continue with no change in payment dates. Your clients will still receive their payments on time.

and access important services, please create an online my Social Security account at: ssa.gov/myaccount/
With a personal my Social Security account, you can view benefit estimates, request a proof of income letter, apply for benefits, request a replacement Social Security card or Medicare card, and much more. It's easy, convenient, and secure.
