20-year sentence for abuse

A Warm Springs man was sentenced to federal prison last week for sexually abusing two minors on the Warm Springs Reservation.

Harold Charley, 39, will spend 20 years in prison and a lifetime of supervised release for the incidents that took place in January 2024.

The U.S. Attorney's Office for the District of Oregon reported that Charley engaged in

sexually abusive contact with two minors between the ages of 12 and 16 over several weeks, according to court documents.

The case was investigated by the FBI and, on Sept. 23, 2025, Charley was charged by superseding information with two counts of abusive sexual contact. He pleaded guilty on Oct. 7.

Charley had been listed as a sex offender prior to this incident.
