The contract for beading of Royalty Crowns is now being drawn up so, if you or someone you should know are interested please submit a written letter with the following information included:

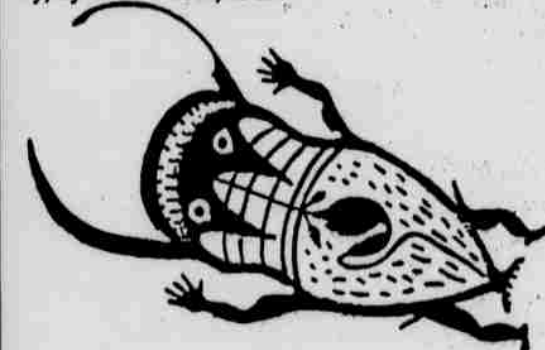
- Total bid amount,

- Design format for both.

Whoever is selected will be responsible to fill the contract which includes:

- Purchasing of beads,
 - Labor,
 - Delivery of crowns by August 1, 1989.
- (If crowns are not delivered by this date, there will be a penalty.)

1989 PAGEANT GUIDELINES FOR SENIOR AND JUNIOR COURTS

Guidelines: LITTLE MISS GRAND RONDE

- 1) Must not be under 7 years old and not over 13 years old by August 18, 1988.
- 2) Must be an enrolled member of the Confederated Tribes of Grand Ronde.
- 3) Must be able to attend all activities, parades, fund raisers and scheduled appearances.
- 4) Must be able to attend all organizational meetings, unless excused in advance.
- 5) You must be drug and alcohol free. Any misconduct will result in disqualification from the court.
- 6) You must be willing, by your behavior, to represent your Tribe in the best possible manner.
- 7) You are expected to show good judgement and not participate in activities that would bring adverse publicity to the Tribe, while you are a member of the court.
- 8) If at any time during the year you become pregnant, you will be disqualified and will lose an title won.
- 9) You are advised to acquire a sponsor - grandmother, mother, aunt, or friend - that can help you with the pageant activities. This is not a requirement, but may be of help to you.
- 10) You must have a ribbon dress, moccasins and leggings.
- 11) You must have a willingness to dance, (assistance will be offered if needed).
- 12) You must have a willingness to speak in front of a large group.
- 13) You are allowed to miss only three out of 15 - 20 events during the scheduled time.
- 14) You will be required to make at least one item of your regalia, and be able to explain why you chose that article and what it means to you.
- 15) You must be fully dedicated to the activities of the pageant.

DEADLINE FOR ENTERING IS APRIL 28, 1989. THERE WILL BE NO EXCEPTIONS TO THIS RULE.

PAGEANT APPLICATION GUIDELINES

If you are interested in participating in the 1989 Royalty Court please take the following steps:

1/ Phone, come in or write (before the deadline) to the Grand Ronde Tribal Office, P.O. Box 38, Grand Ronde, Oregon 97347, or phone 879-5211 in attention to the Royalty Committee. The committee consists of Tammy Fry, Joann McClary, Teri Holsclaw, Darlene Aaron, and Cindy Martin.

2/ Give your name, address and telephone number so we can send you all the required information.

Guidelines: Miss Grand Ronde

- 1) Must be under 14 years old and not over 19 years old by August 18, 1988.
- 2) Must be an enrolled member of the Confederated Tribes of Grand Ronde.
- 3) Must be single with no dependents
- 4) Must be able to attend all activities, parades, fund raisers and scheduled appearances.
- 5) Must be able to attend the organizational meetings, unless excused IN ADVANCE.
- 6) Drug and alcohol free. Any misconduct will result in disqualification from the court.
- 7) Willing, by your behavior, to represent your Tribe in the best possible manner.
- 8) Expected to show good judgement and not participate in activities that would bring adverse publicity to the Tribe, while you are a member of the court.
- 9) You will be disqualified from the court and will forfeit any title won, if at any time during the year you become pregnant.
- 10) You are required to have a ribbon dress, moccasins and leggings for scheduled events.
- 11) It is recommended that you have a sponsor to help you with all activities.
- 12) You must have a willingness to speak in front of a large group of people.
- 13) You must have a willingness to dance, (assistance with dance instruction will be offered if needed).
- 14) You will be required to make at least one item of your regalia, and be able to explain why you chose what you made and what it means to you.
- 15) You will be disqualified if you miss three scheduled events, out of about 15 - 20.
- 16) You must be fully dedicated to the activities of the pageant.

DEADLINE FOR ENTERING IS APRIL 28, 1989. THERE WILL BE NO EXCEPTIONS TO THIS RULE.

3/ Fill the personal information sheet out and the parental consent form (if you are a minor) and return to the above address to bring into the office.

4/ You are officially a participant at the time we receive your information.
