The comment period will include a public hearing on June 18, 1992, beginning at 5:00 p.m. at the Tribal Community Center. Written comments will be accepted to June 25, 1992.

The Tribal Council is interested in community input on substance abuse and its impact on programs and services the Tribe provides. The Council is reviewing the necessity of expanding its current Tribal Drug-Free Workplace Policy, which involves drug testing only under certain circumstances, to a random program.
