

Application Guidelines

The following hunts require that you fill out the appropriate tag application form:

BEAR; 4 Available tags

BOW ELK; 10 Available tags

FIRST SEASON ELK; 26+ Available tags

SECOND SEASON ELK; 14+ Available tags

CONTROL/DAMAGE ELK; 12+ Available tags

In order to apply for tags that require an application form, tribal members must do the following:

*Complete one application per category. Multiple applications will result in all applications being invalid for that individual.

*All applications must be completely filled out and turned into the Fish/Wildlife office by 5:00 P.M. August 9, 1993.

*Any applications received after the deadline will not be considered for the drawing and will be put in the applicant's file. This will include incomplete application forms.

*Tag winners will be announced at a public drawing to be held August 10, 1993 at the Tribal Community Center, 5:30 P.M.

*If you are travelling from out of town to pick up tags, please call ahead to make sure someone will be available to issue you your tags. You may also request your tag by mail. Send your written request to Confederated Tribes of Grand Ronde, 9615 Grand Ronde Rd., Grand Ronde, Oregon 97347. Attn: Fish/Wildlife Department.

All tags will be sent by certified mail only. Any tags returned by mail must also be returned by certified mail. The Fish/Wildlife department cannot be responsible for "lost tags". Any lost elk or bear tags shall be replaced by the tribal member. The cost to replace tags is \$5.50.

Tags will be available during regular business hours, (Monday through Friday 8:00 A.M. to 5:00 P.M.). If you have any questions about 1993 hunting regulations or salmon distribution, please contact Karen Larsen or Karen Lord at 1-800-422-0232.
