New Project — Dan Kauffman Excavating has begun site work for the Tribes' upcoming convenience store and gas station. The company is reprocessing the old asphalt, mixing it with gravel to use for fill for parking and roadway construction. Reusing these materials will save the Tribes about \$12,000, according to Tribal Engineer Eric Scott. This part of the project should be finished by the time this issue of *Smoke Signals* is out, and general contractor PNE Corporation will begin laying the foundations for the building, the gas service canopy and some underground utilities. Project is scheduled for "substantial completion" by late November with a projected opening date in mid-December.

Not all letters are guaranteed publication upon submission. Letters to the editor are the opinions and views of the writer. Published letters do not necessarily reflect the opinions of **SMOKE SIGNALS**, Tribal staff, Tribal administration or Tribal Council.

#### ELECTION EDITORIAL POLICY

In order to ensure a balanced election campaign and fairness to all candidates, the **SMOKE SIGNALS** 2003 Tribal Council Election Editorial Policy for letters to the editor will be as follows: Subject to existing editorial policies regarding libel, personal attacks and unsubstantiated facts.

- 1. Letters in support of candidates will **NOT** be published in regular editions of **SMOKE**
- Letters to the editor from candidates will NOT be published during the time period from nominations to the conclusion of the Tribal Council Election.
- Feature articles and spotlights involving candidates will be suspended during the time period from nominations to the conclusion of the Tribal Council Election.This policy is intended to ensure an equal forum for all candidates.
