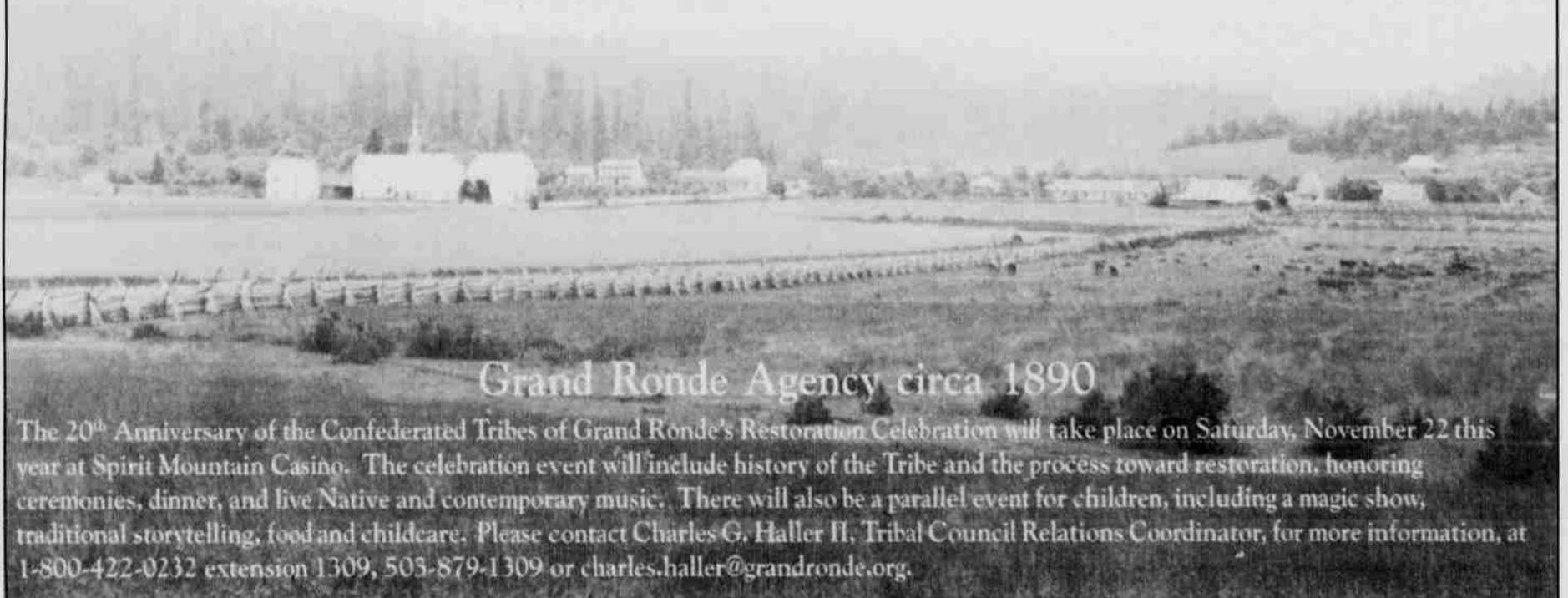


Grand Ronde Tribes Celebrate 20 Years of Restoration Saturday, November 22 — 1983-2003

- 1) Are not a current employee of the Tribe in their "introductory" period.
- 2) Are not a current employee of the Tribe under disciplinary action or performance improvement during the previous 6 months.
