**NOTICE TO AMEND THE CHOICES OF TAX WITHHOLDING PERCENTAGES ON 2006 PER CAPITA PAYMENTS**

During the week of October 16, 2006 a Request for Federal Income Tax Withholding from Per Capita Payment was mailed to Tribal members 18 and older, and gave one choice of 28%. We have amended the tax withholding percentage choices to the following: 28%, 25%, 15% and 10%. Either modify the request form sent to you by writing in your choice of 25%, 15%, 10% or fill out the modified form below and return to the Tribe.
