Notice to Geotechnical Firms: This Request for Proposal (RFP) represents a bid process being conducted by the Grand Ronde Tribal Housing Authority in Grand Ronde, Oregon. Grand Ronde is located 33 miles west of Salem. This is a request for Bid. Responses to this request will be used to qualify applicants for contract negotiations.

The scope of this project is to provide a site-specific investigation/recommendation. This will be used for building design and construction documents in an Elder development on 10.26 acres.

Geotechnical firms wishing to be considered must request a Request for Proposal packet as provided by the Authority and respond to the requirements put forth therein.
