**Confederated Tribes of Grand Ronde
Womens Transition House Project**

Tribal Council met and reviewed project suggestions received from community meetings and surveys and directed staff to prepare an ICDBG application for the construction of a womens transition house. The proposed 3,300 sq. ft. project will house women and women with children and assist them with their transition back into the community coming out of drug and alcohol treatment facilities or prison. The estimated cost is \$667,000 including \$500,000 requested from the proposed ICDBG Grant and \$167,000 from the Tribe. An additional \$30,000 a year in operation and maintenance costs are planned.
