Enrolled Tribal members can request assistance with test fees (i.e. GRE, SAT, LSAT, ACT) and admissions application fees.



ATTENTION TRIBAL MEMBERS WITH CONTRACT **HEALTH SERVICES**

As most of you are aware, Contract Health Services (CHS) is a federally funded program and a payor of last resort. With all of the health care changes recently, we would like to take a minute to remind you that ANY alternate resource you have needs to be utilized correctly. That means in order for CHS to cover a "patient responsibility," you must use providers that are in-network with whatever health care coverage you have primary, including the Tribal Health Assistance Program, Skookum. If you choose not to use providers who are in-network or receive services that are not covered, you will be responsible for any patient balance. Services include: Medical, Dental and Behavioral Health. We apologize for any inconvenience this may cause you, but to keep serving our Tribal community, we must exhaust all other resources available to our membership.

CHS also wants to remind you that there are some services that are not covered by CHS, but are covered by Skookum. If you choose to receive these services, you will be responsible for paying the co-payments. They are as follows: Chiropractic care, Naturopathic care, Massage and Acupuncture, as well as outpatient drug & alcohol treatment. This does not mean that you cannot use those services; it simply means that CHS will not be responsible for any patient balances. You can still keep those appointments; you just need to pay whatever your co-pay is. We understand that this can all be a little confusing, so please feel free to give us a call if you have ANY questions and we'll be happy to help.

The North by Northwest CONNECTOR links coastal communities from Astoria to Yachats! Look for the Connector at major bus stops and transfer points along US 101, or ask your driver for the best way to connect.

what's the cost?

While it's possible to pay individual fares for each bus route, we recommend a 3-day or 7-day visitor pass. These passes may be purchased directly from the Connector drivers and are good for one trip to the coast from Portland, Salem or the Albany/Corvallis area, one return trip, and unlimited travel in Clatsop, Tillamook and Lincoln Counties (from Astoria to Yachats).

You must conduct yourself in a manner that does not interfere with the safety & comfort of other passengers. Disruptive behavior, profanity or vulgar language may result in removal from the bus.
