### TRIBAL EMPLOYMENT RIGHTS ORDINANCE OPEN FOR COMMENT

The Tribal Council is considering adopting amendments to the Tribal Employment Rights Ordinance. The proposed amendments were given a First Reading at the July 1, 2015, Tribal Council meeting.

The purpose of the amendments is to strengthen and clarify the role of the Tribal Employment Rights Office. The proposed amendments include the following:

1. Revisions to the definition of "Qualified."
2. Clarification on the TERO Commission's and TERO Director roles.
3. Requirements for TERO involvement at various stages of the Employment Process including, without limitation, review of candidate assessments and interview questions.
4. Provisions addressing promotions and retention.
5. A prohibition against retaliation.
6. Succession planning requirements.
7. Provisions permitting the issuance of a notice of violation to a Tribal Employer and allowing the Employer to appeal notices of violation to the TERO Commission; and
8. Clarification on workforce goals for contractors.
