Want to get up-to-date and in-the-know about the Grand Ronde Tribe? Well, here's your chance.

In an effort to be more efficient and reduce costs, *Smoke Signals* subscribers can have a PDF (portable document format) version sent to them instead of a newsprint version sent via the mail. All you need on your computer is Adobe Acrobat or some other program that can read a PDF and, viola, you're set.

Why would you want to do that? The PDF version is available before the newspaper is even sent to our Salem printing contractor. You can read the paper on your computer or print out a copy yourself. And you will receive Tribal news much faster than the current standard mailing employed by the Tribe




## **Herron shows**

Grand Ronde Tribal member Monty Herron took third place in the Northern Traditional/Southern Straight Dance competition at the Bay Area American Indian Two-Spirits Powwow held at the Festival Pavilion at Fort Mason Center in San Francisco, Calif., on Saturday, Feb. 4. The Bay Area American Indian Two-Spirits is a community-based volunteer organization offering culturally relevant activities for Native Americans identifying as Two-Spirit. "Diversity and inclusion are at the heart of the BAAITS Powwow mission," said Powwow Committee co-chair Derek Smith of the Sault Ste. Marie Chippewa Nation. "It is currently the world's only Two-Spirit organized powwow and draws some of the area's top dancers together for a day of fun and appreciation of the Native American Two-Spirit tradition."



#### Editorial Board Members wanted

(8) An Editorial Board is hereby created and shall consist of at least three (3), but no more than five (5), individuals. A majority of the Board shall be Tribal members.

(2) Current Tribal employees and employees of Tribal enterprises including Spirit Mountain Casino may serve on the Editorial Board but a majority of the Board shall be comprised of non-employees.

(3) The term of office for an Editorial Board member shall be for three (3) years, except the terms of initial Editorial Board members may be staggered between one (5) and three (5) years.

(4) To be eligible to serve as an Editorial Board member a person must:

(A) Be at least 10 years old;

(B) Have qualified experience in management and/or publication;

(C) Be of good character and integrity; and

(D) Certify he or she will adhere to the standards of accepted ethics of journalism as defined by the Society of Professional Journalists and endorsed by the Native American Journalists Association.

\*The powers and duties of the editorial board can be found in Section F of the Independent Tribal Press Ordinance.
