The Request for Proposals (RFP) is being conducted by the Social Service Department for the purpose of obtaining a contractor who has five plus years' experience in SSI/SSD advocacy/benefit determination and the qualifications to advocate for Tribal members who are seeking assistance in the application process. Qualified applicants shall possess the ability to:

- Provide general information to Tribal members and make referrals regarding SSI/SSD and veteran's benefits;
- Screen Tribal members who claim their disability does not allow them to work;
- Refer members to appropriate physical and/or mental health evaluations;
- Determine the severity of the physical/mental health condition from reports received. Make recommendations and assist Tribal members develop an action plan;
- Assist Tribal members in applying for SSI/SSD and or veteran's benefits;
- Assist Tribal members with completing paperwork to file for appeals for denial of SSI/SSD or veteran's benefits;
- Refer Tribal members to Tribal member benefits to apply for Tribal SSI/SSD program;
- Serve as a resource to employees when working with clients that may benefit from SSI/SSD or veteran services.

Preference will be given to members of the Confederated Tribes of Grand Ronde and or Indian-owned business registered with the Confederated Tribes of Grand Ronde TERO office.

Successful candidates must provide the following insurance:

- Commercial General Liability Insurance limits not less than:
- \$500,000 General Aggregate Limit;
- \$500,000 Personal Injury;
- \$500,000 Each Occurrence Limit.


