Want to be one of the first Tribal members to receive *Smoke Signals*? Want to receive the Tribal publication on your computer instead of waiting for it to arrive in the mail?

Want to get up-to-date and in-the-know about the Grand Ronde Tribe? Well, here's your chance.

In an effort to be more efficient and reduce costs, Smoke Signals subscribers can have a PDF (portable document format) version sent to them instead of a newsprint version sent via the mail. All you need on your computer is Adobe Acrobat or some other program that can read a PDF and, viola, you're set.

Why would you want to do that? The PDF version is available before the newspaper is sent to our Salem printing contractor. You can read the paper on your computer or print out a copy yourself.

And you will receive Tribal news much faster than the current standard mailing employed by the Tribe.

ENROLLMENT ORDINANCE **OPEN FOR COMMENT**

The Tribal Council is considering amendments to the Enrollment Ordinance. The proposed amendments were given a First Reading at the Sept. 13, 2017, Tribal Council meeting.

The purpose of the proposed amendments is to: (1) allow Tribal members or applicants to view, in the presence of Enrollment Staff, electronic versions of their entire enrollment file and the enrollment files of lineal ancestors, except adoption records, and provide related procedures; (2) provide that the Tribal Roll is not subject to the Ordinance's confidentiality provision; (3) add a provision for issuance of Descendancy Letters or Certificates of Descendancy; (4) provide that Tribal Council makes final decisions on loss of membership; and (5) provide procedures on Enrollment Board loss of membership recommendations to Tribal Council and loss of membership hearings before Tribal Council.
