Opportunity for comment on 2017 Annual Performance Report (APR) for Housing

Under the Native American Housing Assistance and Self-Determination Act of 1996 (NAHASDA), the U.S. Department of Housing and Urban Development (HUD) will provide grants to eligible Indian Tribes/Indian Housing Authorities for the development and operation of low-income housing in Indian areas. To be eligible for the grants, respondents must submit an Indian Housing Plan that meets the minimum requirements of the Act, and also submit an Annual Performance Report to HUD and maintain records for HUD monitoring. The Tribe, through the Grand Ronde Tribal Housing Department (GRHD), received multiple grants under this program which were active during 2017. Comments on the Annual Performance Report are welcome and copies of this report can be obtained at the Housing Department office or by calling 503-879-2401 or 1-800-422-0232, ext. 2401. Comments must be submitted in writing to GRHD no later than 5 p.m. Wednesday, March 21, 2018.

All comments will be incorporated into the final report submitted to HUD. ■
