Public Notice Open for Comment

This is a Public Notice for Comment on the Grand Ronde Tribe's application for 2021 Low-Income Home Energy Assistance Program (LI-HEAP) Funding. The Grand Ronde Tribe obtained a LIHEAP grant last year from the Division of Energy Assistance within the U.S. Department of Health and Human Services. This grant program assists income eligible Tribal members with energy assistance (utility bills, firewood, etc.), cooling assistance, crisis energy assistance, and weatherization (e.g. furnace repair, caulking, insulation).

The Tribe's LIHEAP service area includes Polk, Yamhill, Marion, Multnomah, Washington, Tillamook and Clackamas counties. If you are interested in obtaining services from the current program, please contact Social Services at 800-242-8196 for energy assistance and Tribal Housing at 503-879-2405 for weatherization.

The Tribe is taking public comment on the 2021 LIHEAP application and plan and the associated policies that are to be submitted by Sept. 1, 2020. The latest draft will be available for review at the Social Services Department at the Community Services Center starting Aug. 14, 2020. Please Bring

- A Government Issued ID (driver's license, tribal ID, birth certificate, vaccination record, WIC ID, etc.)
- Proof of Residency (a piece of mail with your name and address on it)
- Oregon Health Plan Card (if you have one)
- Paystubs for last 30 days (if you have them)





Steps to becoming a Court Appointed Special Advocate (CASA):

- Chat with Tribal Court staff about CASA volunteer work
- · Complete the application and authorize a criminal background check
- Submit authorization for child welfare history check
- · Come in for formal interview
- Complete 40 hours of initial or pre-service training and court observation

You must complete all steps above before being sworn in as an active CASA volunteer. You may be screened out at any point prior to swearing in. The preservice training will familiarize you with the needs of children who have been abused or neglected, the CASA's role and the Tribal Court and Child Welfare Systems.
