- The Petitioner has not petitioned and been granted a change of name by the Tribal Court within the past twelve (12) months;
- The Petitioner has no Creditors or Former Spouses to whom an obligation is owed under a divorce decree.

- The Clerk of the Court shall provide a certified copy of the Order to the Oregon State Department of Vital Statistics.
