I love you and I miss you, bro. May you rest in peace.

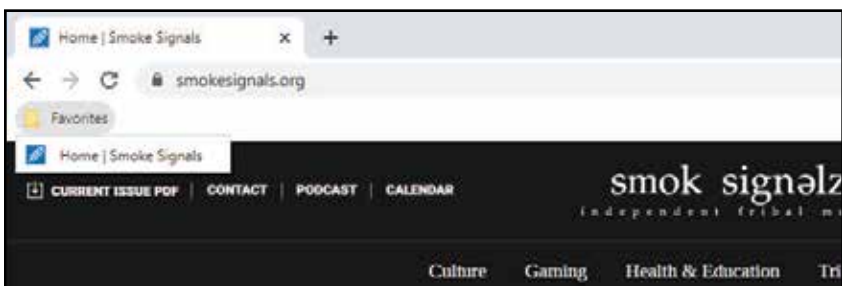
