## EDITORIAL NOTES.

At Ho. Ho 50,000 Filipinos have sworn allegiance to the United States. This is going a long way off to make American citizens.

A West Point cadet gave football a center shot when he gave his opinion that having, at that place, was not so bad as football, and although either is a menace to life and limb, neither justifies the other.

Representative Hume is looking after a legislative measure to provide better protection to salmon in Kogone River. During the twenty odd years we have lived in Curry and Clatsop counties Mr Hume has looked after those salmon a little closer than any one else and we surmise that his greatest interest now is to protect them from the other fellow.

The Philippine Commission is after the rebellious Tagals now with a large caliber gun. Realizing the desire and hope of the average mortal to hold office, that body has passed an act declaring all persons in arms against the United States authority or aiding or abetting the insurrectionists, after March next, ineligible to office. If this decree does not conquer the Filipinos Uncle Sam will have to get down to hard fighting.

New comes an expression of a hope that sympathy expressed in this country, for the dead queen of England, may settle the Niagara canal question in our favor. This is rather a far-fetched and preposterous hope, and it is more likely that the death of two or three hundred influential American citizens who oppose the canal, and the downfall of as many American institutions which are striving to defeat the measure, would be more beneficial than the sympathy which might be lavished on half a dozen departed queens.

The Pope has issued his encyclical on socialism, but as true socialism is part and parcel of the Golden Rule it will grow and flourish. The best sign of its great and rapid growth is the opposition it is receiving in high places, and as socialism implies nothing but what is right between man and man why should any person oppose it? There is no good reason except that men are selfish and do not wish other persons to enjoy what they wish to possess alone. Socialism has its reward and things will not continue in its train.

The Ship Subsidy beggars are still persistently at work devising ways and means to squeeze their net bill through Congress to further burden labor and the producing classes. This scheme is urged ostensibly to aid American shippers, but in reality to make a very profitable investment for some of the surplus wealth that has accumulated in the hands of the wealthy. Is it not enough that the bone and sinew of the laborers have been taxed to build and maintain these wealthy holdings without having the hand of the government reaching into the pocket of each toil or after the toil retained as a recompense of his toil, and for the purpose of giving it to those rich beggars? Each man who favors that infamous scheme should think with shame every time he looks an honest American in the face.
