To Prospect For Oil.

Some months ago we made mention of a discovery of natural gas that was made on William H. Button's ranch, situated on the north side of Floras creek, and a mile east of Dairyville.

The discovery was made while sinking a well for water and the gas was in sufficient quantity to blow out with a whistling sound making quite a noise.

Since then Mr. Button has been busying himself quietly in devising plans and means to prospect the find and the result is that a local company of Coos county business men with a capital of \$5000 has been raised to investigate and see what can be found under the surface of the ground in that part of the country.

With this object in view, Mr. Button left here yesterday morning, for Marshfield, to secure the use of a diamond drill with which to sink a prospect hole at or near the point of discovery.

The company proposes to drill a hole into the earth to the depth of three to five thousand feet unless a strike is made sooner. Mr. Button expected to get back to Bandon today with his drilling apparatus, and thinks that the company will have the drill in operation in about two weeks.

Important News Notes

TUESDAY Aug 14

A Boston company has secured an immense bed of coal at Cape Nome. The vein is forty five feet in thickness.

Six lives were lost in the burning of a tumble down tenement in New York.

Bank wrecker Frank Andrews of Detroit got fifteen years at hard labor, but got out on a writ of error.

The Wild Goose Mining Company put in a pump at Nome, Alaska that cost half a million dollars, and lifts 4,000,000 gallons of water daily to the top of Anvil mountain.

Five officers, thirty men and seventy chinees were drowned by the sinking of a pontoon on the Anar river in Asia.

WEDNESDAY Aug 20

A British ship arrived at Astoria yesterday having Cholera aboard.

The Boer Generals visit President Kruger.

Trains collide in New Jersey, two men are killed, one fatally hurt and several persons injured.

Samuel Seelye who served a long sentence for stealing \$250,000 has returned to New York a millionaire.

Automobilists in the Rhine Province, Germany, ran over a man and two children, with fatal result and narrowly escaped lynching by the peasants.

THURSDAY Aug 21

A gang of five green-goods men and one woman were arrested in New York and their paraphernalia captured.

The Sultan of Turkey has got a move on in the matter of fulfilling his agreement with Uncle Sam. He will now rebuild the American mission destroyed at Kharpout, and let women and children join their husbands and fathers who have become naturalized Americans.

Sheriff Davis was wounded in an attempted jail break, at Centerville, Iowa. His wife seized an ax and helped the deputy sheriff, who was armed with a revolver, to force the prisoners back.

Excursion trains collided in Nevada and two men were injured.

Eleven men were killed by the explosion of a pulp digester at Wilmington, Delaware. Six others are thought to be buried in the ruins.

The inability of the railroad to handle the demand for coke have caused a shut down of several furnaces in the east.

Thirty-five deaths from Cholera occurred in the Philippine division of enlisted men, between June 25 and July 10.

The messenger boys strike caused a couple of small riots in Chicago. Men employed to take the place of the strikers, quit work rather than incur the enmity of the boys.

A San Francisco jury found Frank Woods guilty of the murder of policeman Eugene Robinson.
